## Riding and Video Taping Schedule

A minimum of two paid practice lessons must be scheduled with Stacy Sutton in advance to qualify for show participation. We will be adhering to specific COVID-19 safety protocols. You will receive a copy of the protocols before your first lesson and are expected to follow them for everyone's safety. Once you feel ready, your dressage and WE course classes will be video taped and sent to our judges. Callers for dressage & courses are allowed at BOTH levels. All final show video rides must be taken on **AUGUST 23rd and 30th, 2020**. (special alternate video date can be made if needed) Show results will be announced and tests will be available on **September 6th, 2020**.

You will receive your tests back via email or mailed by request. Show rules will adhere to WE United rulebook, however, judge and management have final discretion. There will be prizes for all entries.

## Stabling and Arenas

Due to COVID-19 restrictions NO stabling is available at this time.

Full sized dressage court with excellent footing, large, fenced warm up covered arena, and there is a covered round pen for lunging horses.
